1. To register your child/children you must provide:
 - a. Completed registration form
 - b. Completed emergency medical form
 - c. Copy of the child's birth certificate (there will be a copier at sign ups to make copies if need be)
 - d. Payment
 - i. Payment may be made with cash or check
2. A separate form must be turned in with each child
 - a. For a family with multiple children involved, the oldest child will be charged full price with each additional child receiving a \$5 discount.
3. The above items can be turned in at:
 - a. The high school & elementary school offices
 - b. The Pioneer Village offices
 - c. In person sign up
